The Chair of the Presidential Search Committee meeting, Dr. Wadsworth, called the meeting of the Presidential Search Committee to order on Wednesday July 31, 2013 at 2:04 pm.

The presidential panel date was confirmed for Friday, August 30, 2013 following the Board of Trustees meeting. The next full committee meeting was announced for Friday, August 16, 2013. Professor Merritt gave a summary report of the Advisory Subcommittee's activity to date. Professor Merritt reviewed the draft plan for gathering input from constituent groups.
