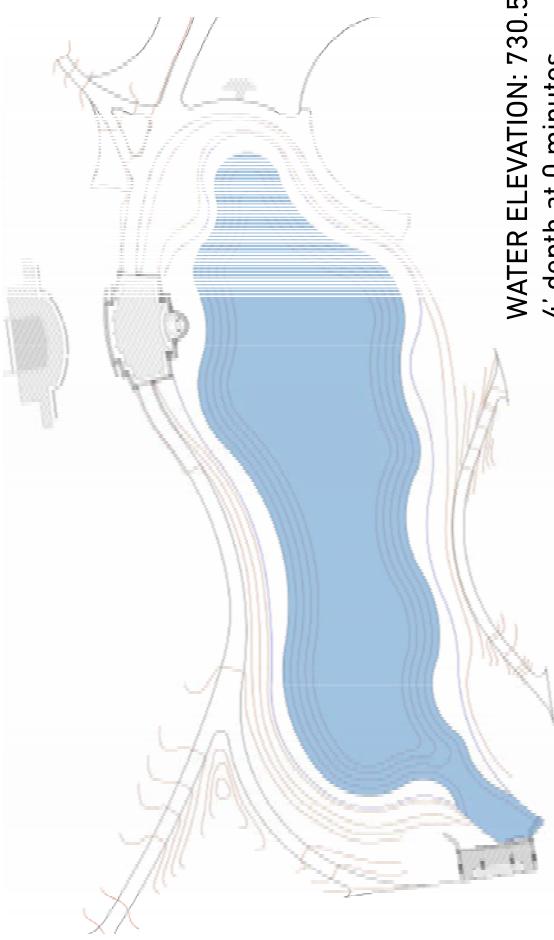
2/ Pond Edge & Planted Buffer

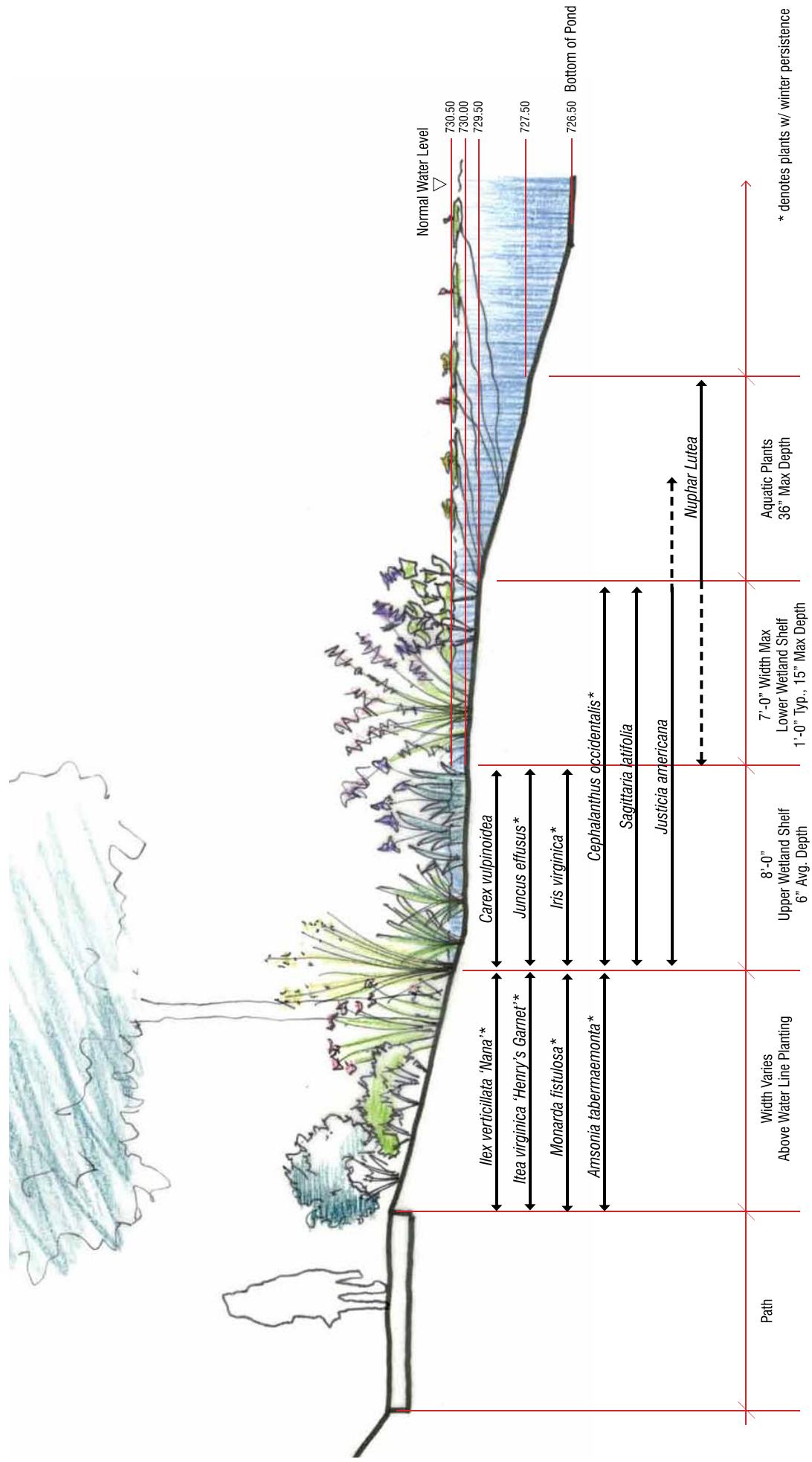

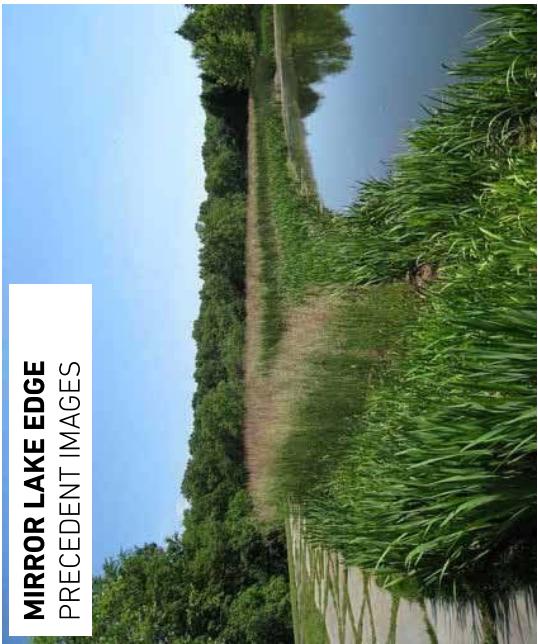

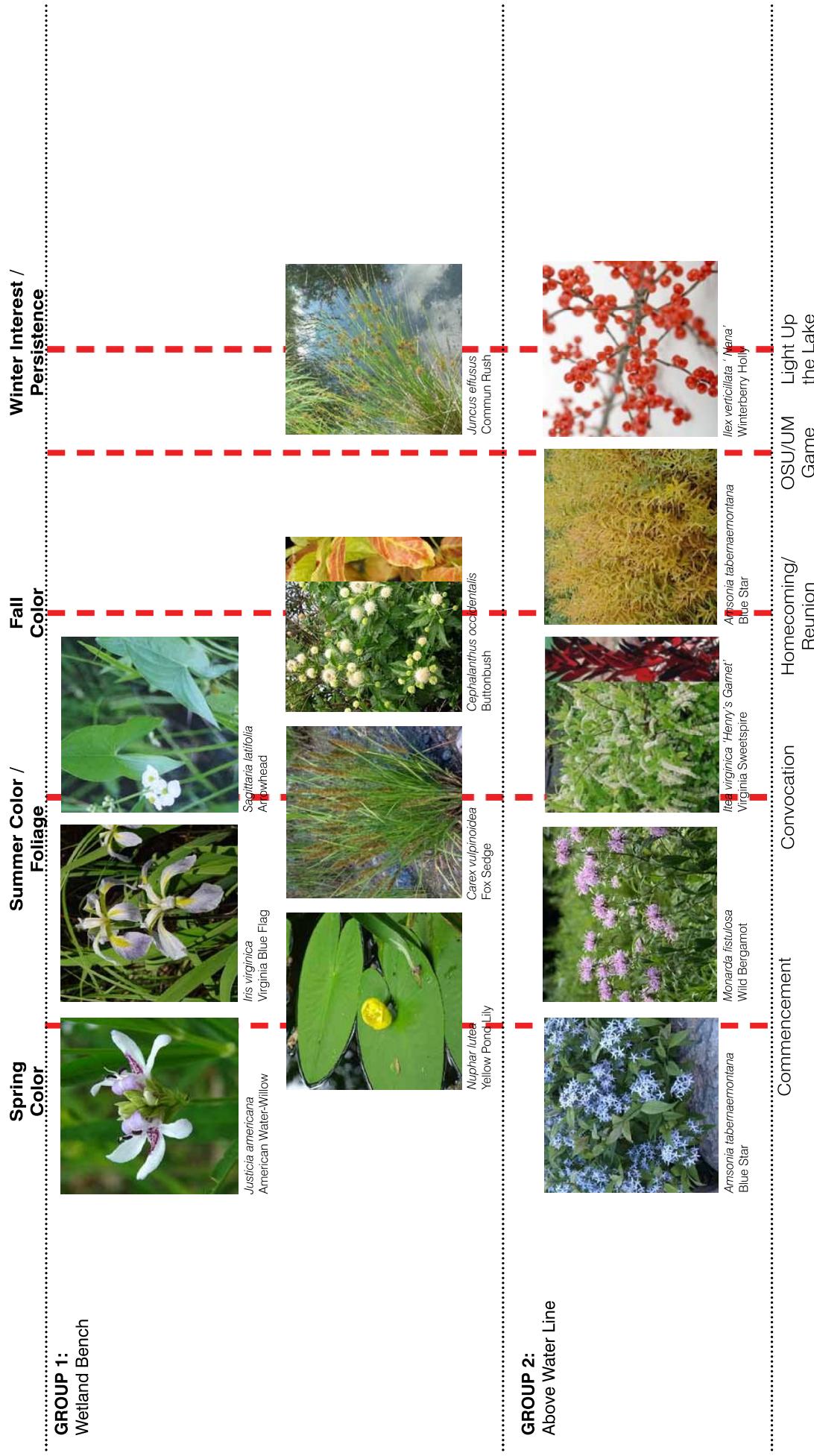
DRAWDOWN SCHEDULE

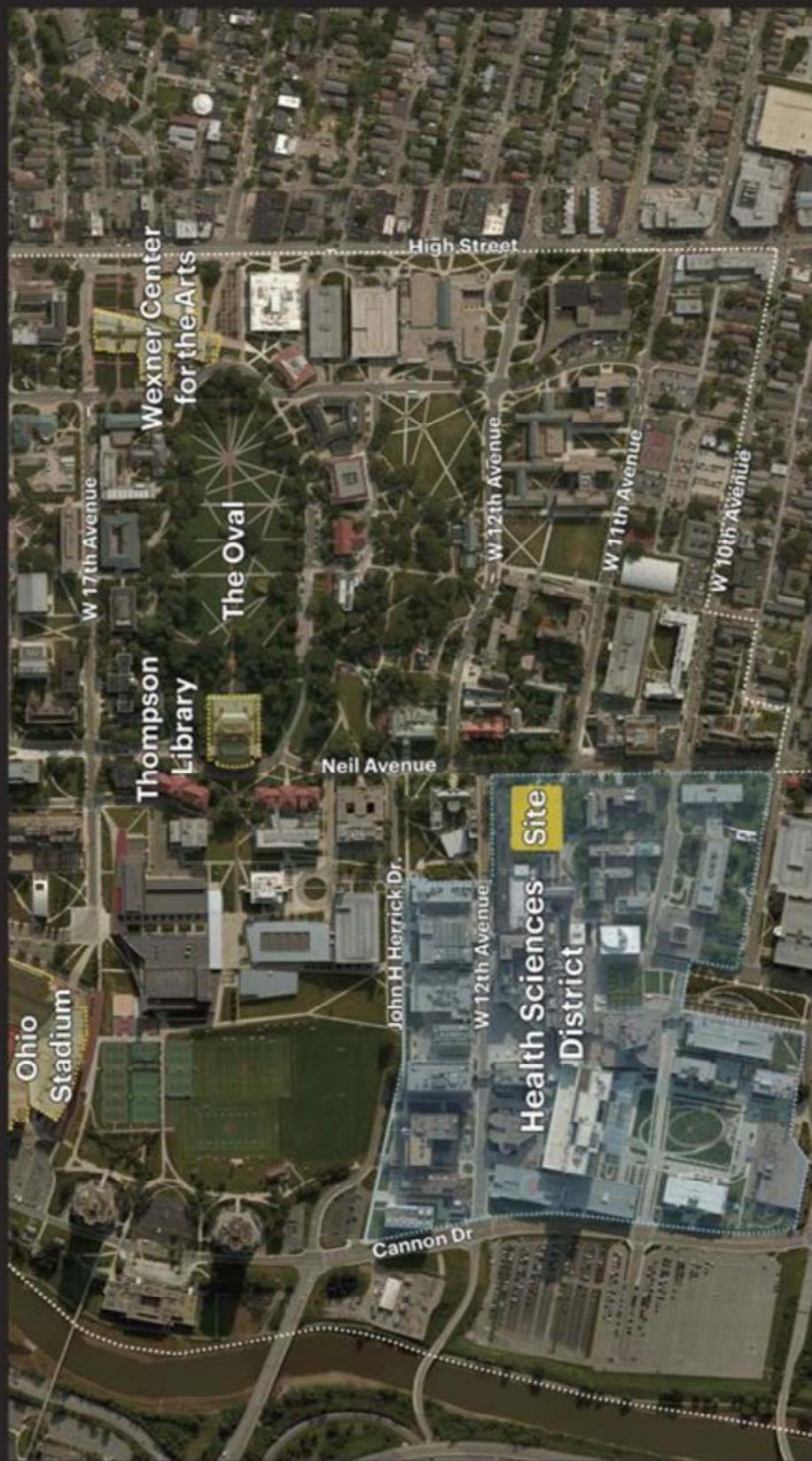

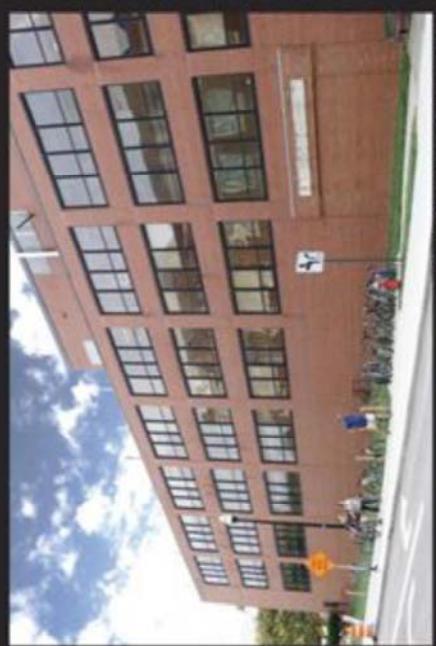

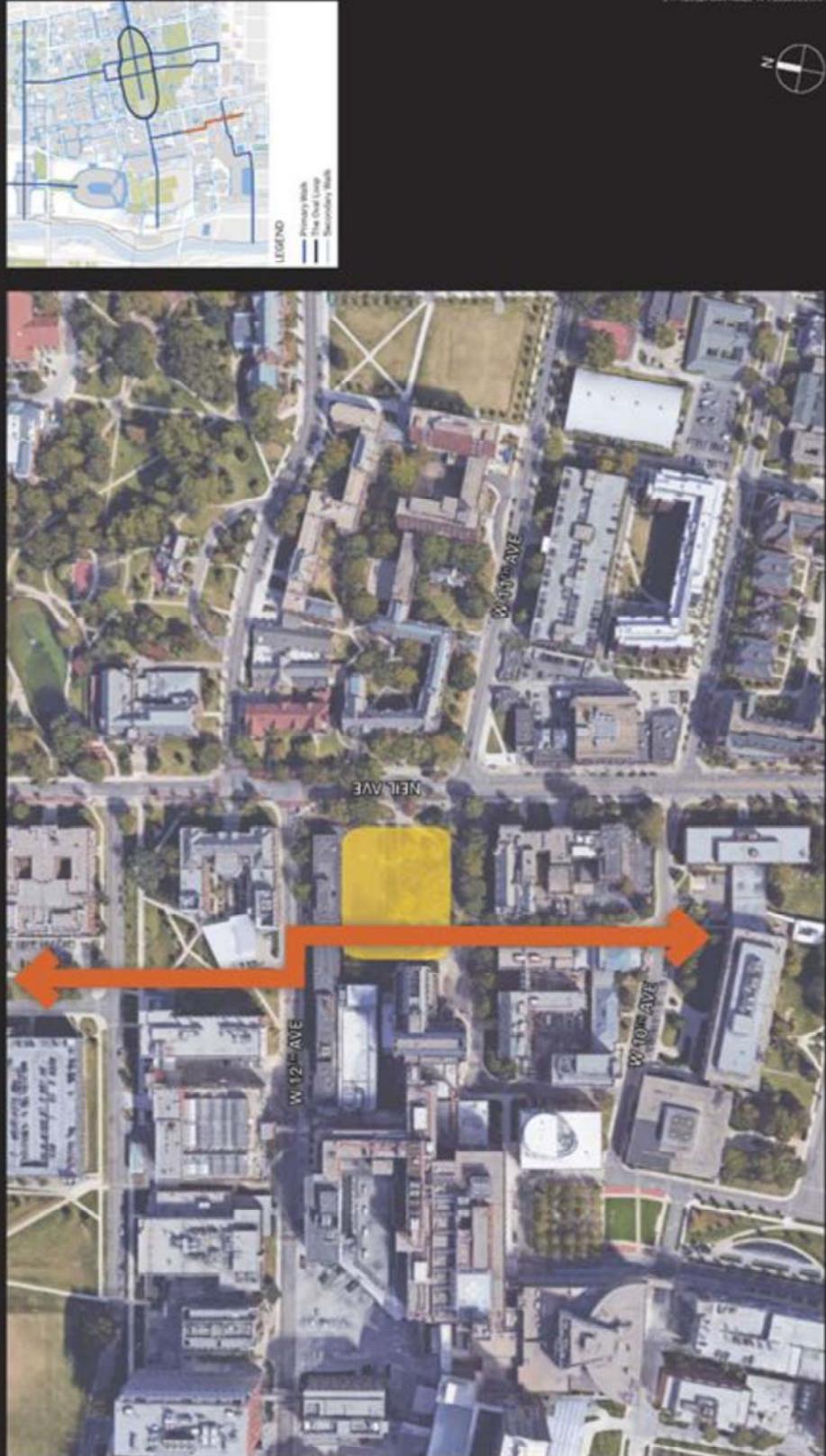

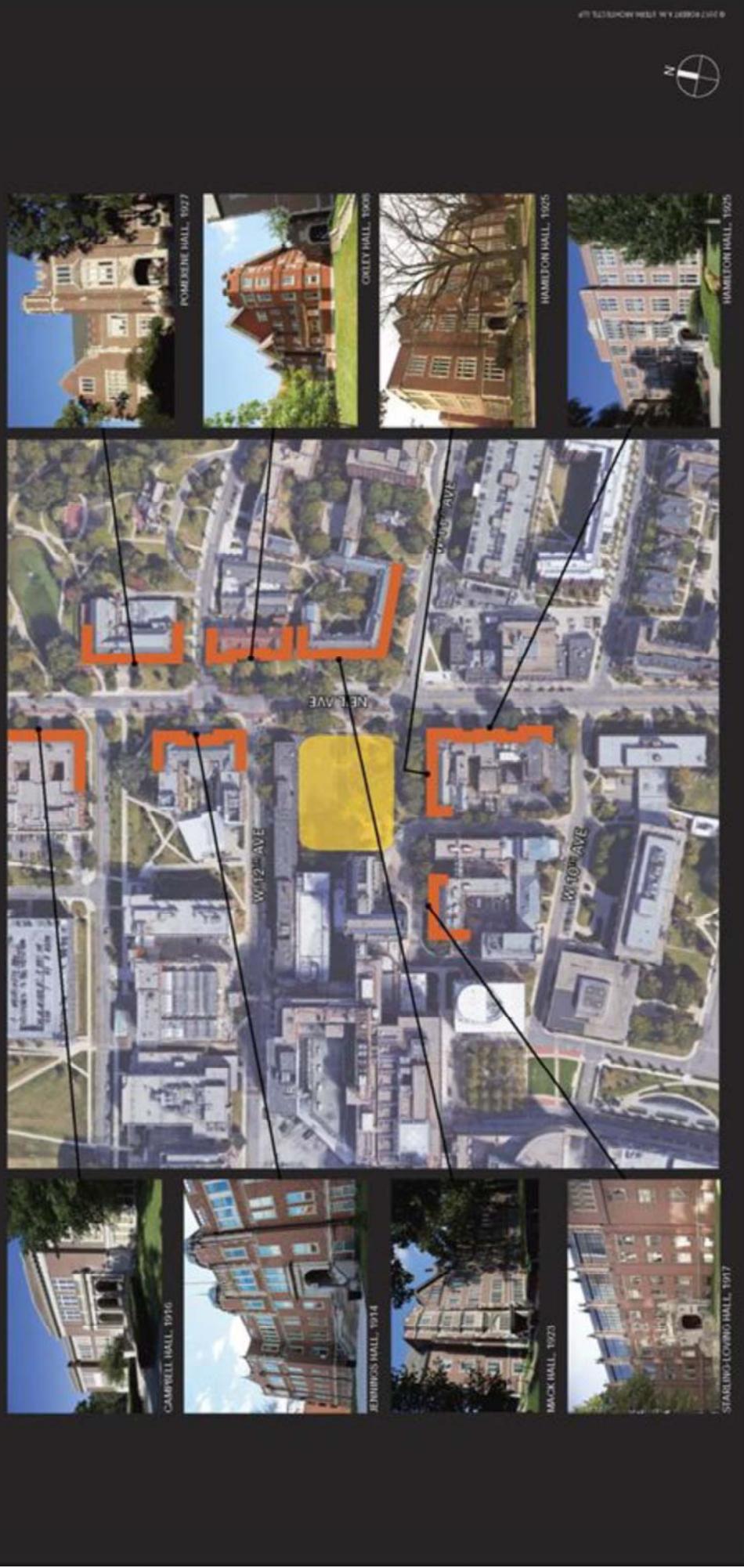

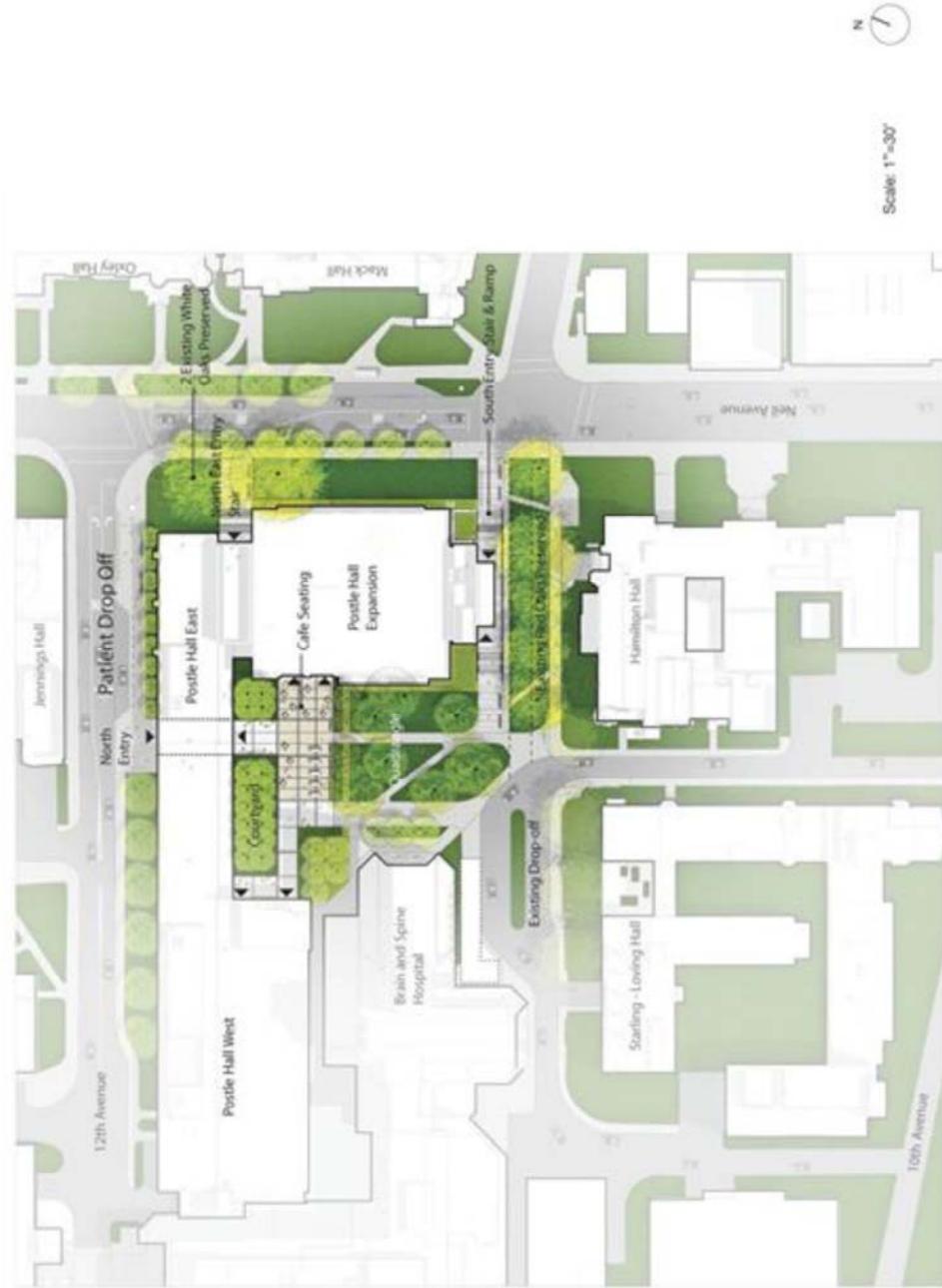




Site Plan - Existing



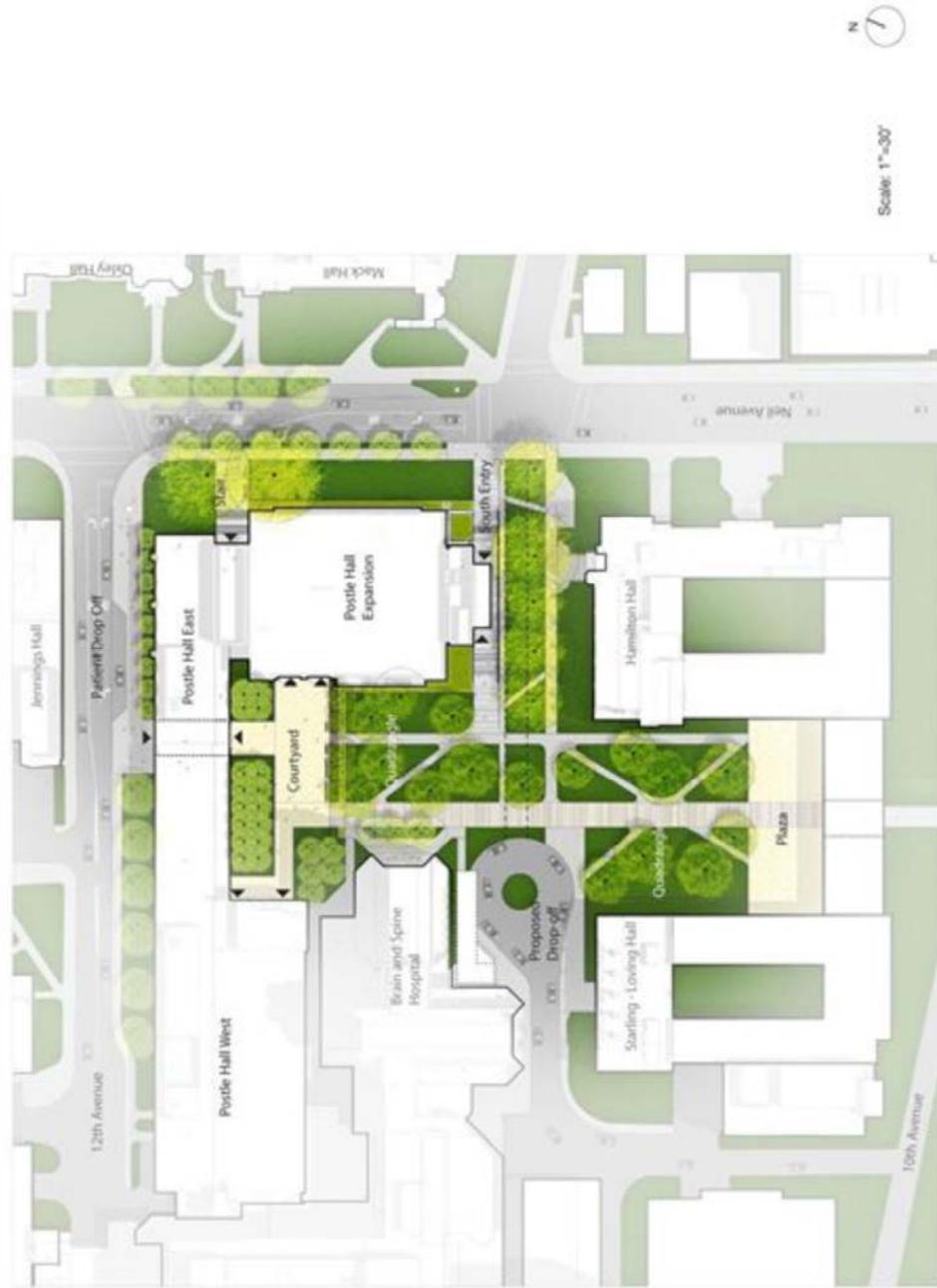
Site Plan - Proposed

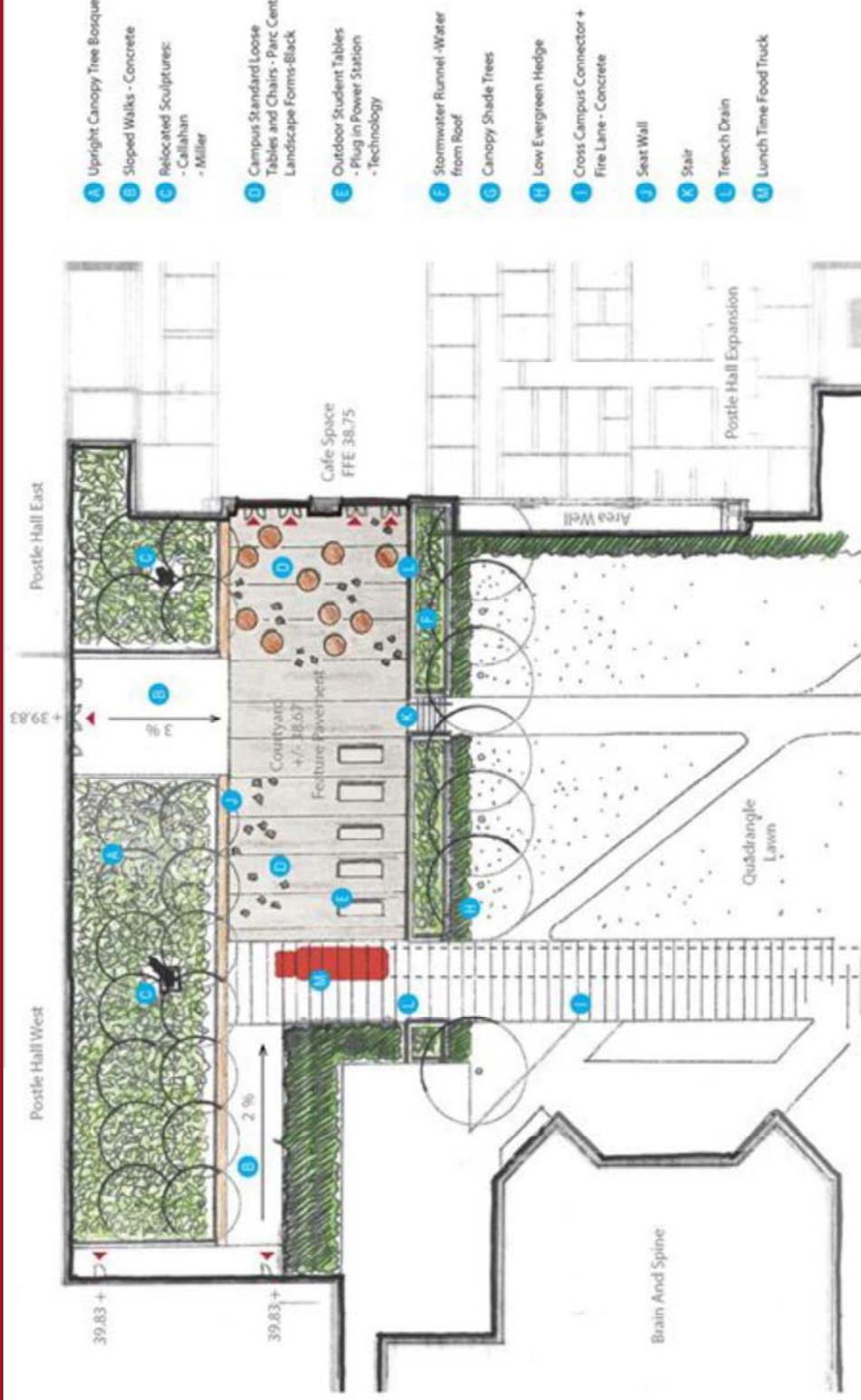

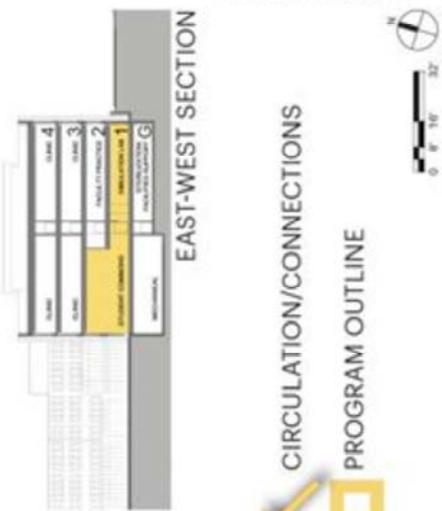

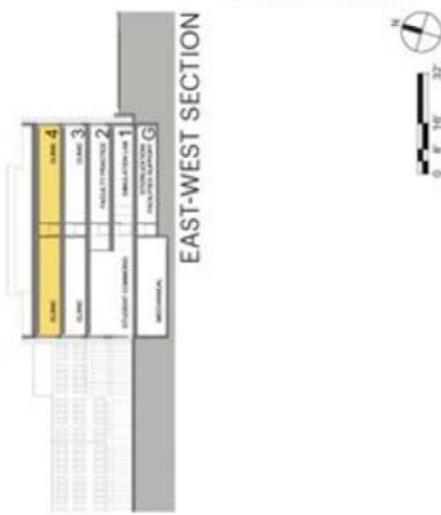

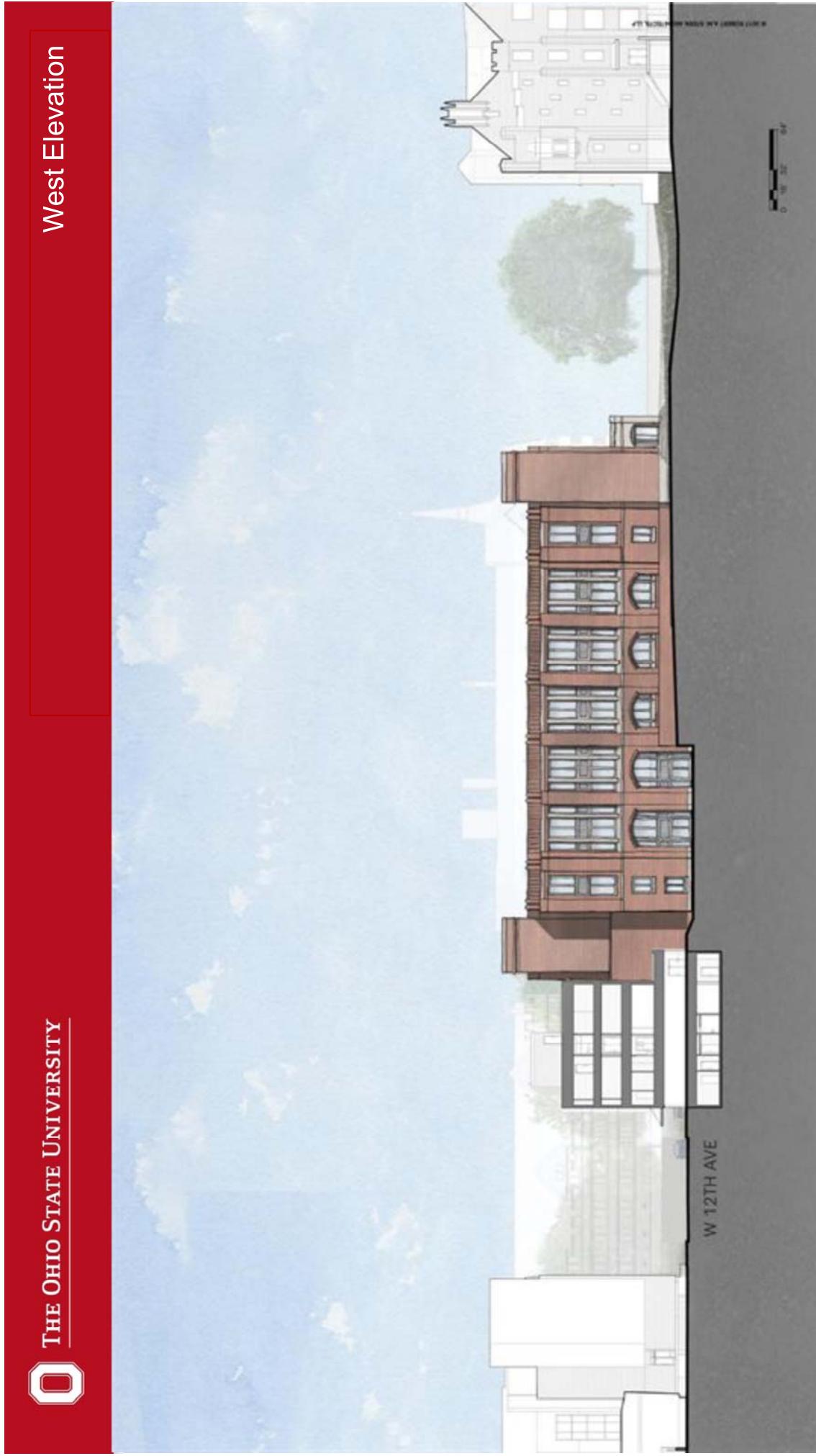
